If the verification reveals that the claim to belong to that particular State against whose vacancy your selection has been made is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code.
- xiv. You will be subjected to fresh medical examination at the time of reporting to RTC, if the validity period of 18 months from the date of fitness to joining service is over in terms of recruitment medical guidelines issued by MHA vide UO dated 20/05/2015 and MHA UO dated 16/04/2021.
